Application Deadlines:

- Early entry status will be granted to all 2017 exhibitors in good standing and to artists invited by the organizers to participate. Please submit completed application and fees by June 30th, 2018. All remaining spaces will be considered open - effective July 1st, 2018.
- Note – This is a juried show - new exhibitors must submit three photographs of their work with their application. (Returning artists will also be asked to submit photos to be used in promotional material for the show.)

Definitions:

1. **Artist:** Exhibitor whose work is being sold. Must be present at the show.
2. **Commercial vendor:** Exhibitors selling items complementing the work of artists. Commercial vendors may only sell products that the organizers do not consider as competition to the show's bead artists. Vendors will be asked to remove any other products and failure to comply could result in exclusion from future shows.

Terms and Conditions:

1. The exhibitor agrees to sell only those products listed in their application and which are accepted by the show organizers.
2. First-time artist exhibitors are limited to a maximum of one full table. Returning artists and commercial vendors may request up to TWO tables. Special consideration will be made for commercial vendors up to a maximum of 3 tables
3. Vendors may not extend in any direction beyond their assigned space or use another vendor's unused space without the prior approval of the show organizer. Vendors infringing on the space of their neighbours will be asked to remove excess displays.
4. One electrical outlet is provided for each booth to a maximum of 200 watts/vendor.
5. Exhibitors will supply their own floor-length table coverings. These can be ordered for a minimal fee by contacting the show organizer in advance.
6. All exhibit space is to be kept neat, tidy and clean at all times during the show.
7. The exhibit space is to be manned at all times during show hours (artists must be present). If you are alone, you will have access to volunteers to man your table for short absences.
8. All exhibitors should be prepared to unload and pack up their merchandise. As set-up time may be limited, some volunteers will be on site to help exhibitors move their merchandise to assigned booths.
9. Vendors are reminded to secure their merchandise while in transit, during set-up and on the show floor. The room will be locked overnight.
10. All exhibitors will act in a courteous and professional manner at all times.
11. Exhibitors will keep their display completely set up until the show closes on Sunday at 5pm.
12. **Please Note that the RA centre is a non-smoking property. Smoking on the premises will not be tolerated.**

Liabilities:

13. The Show continues under the corporation name: GSS Flameworking which has a blanket insurance policy covering the OGBS, that said, our insurance company does still recommend that each seller/instructor carry their own liability insurance (check with your company, but normally it is \$2 million Commercial General Liability).
14. All exhibitors accepted into the show release and hold harmless the organizer (GSS Flameworking) and their employees and agents and the RA Centre from any liability for losses or damages resulting from this event.
15. Each vendor is responsible for collecting all applicable taxes. If you are uncertain of your status, contact the Ontario Ministry of Finance at 1-888-565-6433, <http://www.fin.gov.on.ca/> and the Ontario Ministry of Revenue at 1-866-668-8297, <http://www.rev.gov.on.ca/en/tax/>.

Cancellation Policy:

16. Exhibitors cancelling 30 days or less before the show are subject to a penalty of 50% of their space fee. Exhibitors cancelling 15 days or less before the show will forfeit their space fee.
